**DOGS: Rabies, Distemper (DHLPP), Bordatella (Kennel or Canine Cough).
Vaccinations should be given 10 days prior to boarding to be the most
affective. Contact us for any questions. Lepto vaccine is recommended.
Monthly heartworm preventative is recommended.**

**CATS: Rabies and Feline Distemper (FVRACP). Feline leukemia vaccine is
recommended.**

****FLEA PREVENTION medication is required for both dogs and cats, and is
routinely documented each visit.**

**A Copy of Current Vaccinations must be kept on site. We cannot accept pets with
expired records.**

Bed and Breakfast Boarding Contract

1. **The client upon services rendered shall pay for any additional necessary costs such as food, supplies, or vet fees.** We give Funny Farm Petcare permission to take our pet(s) to the veterinarian or contact the veterinarian as necessary. Each trip to the vet’s office or to get necessary supplies will be assessed a \$25 dollar charge for local area (within 15 miles), along with any medication and fees incurred from the appointment, additional fees may apply outside of local areas, or out of the ordinary vet visit. Funny Farm Petcare also reserves the right to bathe and groom any animal that becomes soiled during the pets stay at owner’s expense.
2. If a client knowingly or intentionally brings a “**dangerous or vicious pet(s)**”, the client is **fully** liable for any and all damages including but not limited to hospital fees, damages, and court costs. **Pets must be friendly enough for our staff to handle.**
3. **Funny Farm Petcare and its employees agree to provide the services stated in this contract in a reliable and trustworthy manner.** In consideration of these services and as an express condition thereof, the client expressly waives and relinquishes any and all claims against Funny Farm Petcare and its employees, unless arising from negligence.
4. Funny Farm Petcare is **not responsible** for any **damaged or lost items.**
5. The **client** fully understands the contents of this contract, and by signing below **takes full responsibility for payment** of all reasonable and customary charges **upon services rendered.** All costs of collection as a result of non-payment including attorney fees shall be paid by the customer. **A late charge of \$20.00 may be added if payment is not received within 10 days of services rendered or for any returned checks.**

Pickup’s and Drop-off’s are during our set office hours. Missed appointments without prior notice, may incur an additional \$25 charge, along with any other fees that apply. Anything outside of set office hours may also incur a \$75.00 fee.

Changes in appointment times: Please give 24 hour prior notice.

Cancellation Notices: Please give 3 days prior notice to the reservation (other then holidays).

Holiday Cancellations: Please give 14 days prior notice to the Holiday(set by our facility).

All Pets must be ON Leash while entering and exiting our Facility.
